About our trading approach.

The roots of our trading approach go back to Joe Ross and everything we have learned from him from 2003 to now. The approach is quite simple:

While the entry can be based on "gut feeling", the trade management is based on fixed rules. We need a low-risk per contract on our entry, because we want to trade as many contracts as possible. Sometimes we are able to trade 4 or even more contracts, and can keep the average risk per trade still at approx. 1% of our trading account (approx. \$50k).

How much does it cost?
